

1 **NYE COUNTY RESOLUTION NO. 2017-87**

2 A RESOLUTION DIRECTING THE LEVY OF A SPECIAL ASSESSMENT ON ALL TAXABLE
3 PROPERTY SITUATED WITHIN THE CONFINES OF THE PAHRUMP VALLEY
GROUNDWATER BASIN FOR FISCAL YEAR 2018-2019

4 WHEREAS, pursuant to NRS 534.040 the Nye County Board of County Commissioners (Board)
5 is required to fund the 2018-2019 budget for Nevada State Water Engineer's supervision over of the
6 Pahrump Valley Groundwater Basin, No. 162, in the amount of \$55,000.00; and


7 WHEREAS, in order to generate the revenue needed to fund the budget the Board must levy a
8 special assessment at the rate of one dollar thirty cents (\$1.08) per taxable parcel of real property located
9 within the Pahrump Valley Groundwater Basin, which said special assessment will generate
10 approximately \$55,000.00 based on the current count of taxable parcels located within the Basin; and


11 NOW THEREFORE, BE IT RESOLVED, that effective for the 2018-2019 fiscal year there is
12 hereby imposed a special assessment at the rate of one dollar thirty cents (\$1.08) on all taxable parcels
13 of real property within the Pahrump Valley Groundwater Basin, to appear and be collected with the first
14 quarter tax billing, which said special assessment shall be a lien upon the property.
