### Instructions for "Affidavit for Correction of a Marriage Certificate"

By law, the recorded Marriage Certificate cannot be altered. You may record an affidavit for correction if you desire. If you record the affidavit for correction, then you would be able to present a certified copy of the original marriage certificate and a certified copy of the affidavit of correction you have recorded.

Please be advised that the recording of this document may not solve your legal problem. This office always suggests that you seek legal advice pertaining to your particular situation.

To record the Affidavit:

1. Contact the Clerk's Office to correct your marriage license.
2. Fill out the Affidavit of Correction of a Marriage Certificate (This is not the Affidavit for Correction of Marriage License Application, that is to correct the application, not the certificate.) If you would like to attach the Marriage License Correction you may but it does not replace the Affidavit of Correction of Marriage Certificate form.  
*Note: Do not put anything in the 3"X 3" area in the upper right-hand corner of the first page of the document.*
3. Complete the form & sign the document in front of a Notary Public.
4. We recommend you attach your original incorrect marriage; you must purchase a certified copy for \$15.00 or use your original.
5. Return the affidavit to the Recorder's Office for processing along with the recording fee (\$37 for the recording fee plus \$15.00 for each certified copy you would like to purchase) made payable to the Nye County Recorder's Office.
6. You cannot correct the "wishes to use the name" portion after they are married. Per NRS 122.040. Note - You can correct a typo error you can't change the names completely. Prior to correcting this in our office, you need to correct your license with the Clerks Office.
7. You do not need to contact the Clerk's Office if you are correcting any of the handwritten portions of the Marriage Certificate.

We will record the affidavit and return it to you. Please contact our office if you have any questions.
